Course Description:

This course has an emphasis on the computer skills and knowledge you need to be an effective professional in today's work environment. Emphasis is placed on keyboarding, word-processing, spreadsheets, and presentation software. An introduction to the Internet is also included.

Learning Outcomes:

Students who successfully complete this course will be able to:

- Define, explain, and describe key terms, concepts, theories, models, and techniques learned from this course.
- Understand the basics of how a computer operates and how it can be used to enhance work productivity.
- Understand the fundamentals of finding help and be able to demonstrate the use of different support resources to solve basic software-related problems.
- Understand the basics of the internet, and how to use it effectively to enhance work productivity.
- Understand the basics of computer security, and be able to discuss preventative and corrective solutions to security-related problems.
- Demonstrate an understanding of social networking, some of the leading resources, as well as some of their strengths and weaknesses.
- Use Microsoft Word, Excel, PowerPoint and other related software for business applications.

Course Format:

This course is delivered in a computer lab, and uses a variety of teaching/learning methods that may include discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in class discussions and lab tutorials, and take responsibility for your own learning. Be a positive and co-operative team member. Columbia College uses a facilitation model of instruction where the facilitator's role is to facilitate your learning. The expectation is that you will come to class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you have a tendency to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

Submission and Completion of Assignments:

Each journal assignment should be accurately titled, be 250-350 words in length, and contain a link to the original article, app, or website. Each set should follow APA formatting and include a title page. In your journal, you must provide the following:

IT News Story Journal:

What is the story? Why is it relevant? Reaction from community? Impact on industry and/or future career path? Is the resource credible (why or why not)?

APP Review:

What is the application, computer program, or computer device? Why is it relevant? Reaction from community? Impact on industry and/or future career path?

Website Review:

What is the website's purpose? Why is it relevant? Is the website credible (why or why not)? Impact on industry and/or future career path?

The Computer Learning Journals will be worth a total of 20%, and will be graded on the following:

1 Mark	Appropriate Sources Used and Cited (ie. a cite or topic related to your career)
1 Mark	Content (falls within the 250-350 length and contains minimal spelling, grammar or punctuation errors)
1 Mark	Appropriate Title and link to original site.

Final Exam

Due Date: Class 10

Weight: 30%

Students will be required to write a combination multiple-choice and/or skill-based final exam covering the content of classroom learning and assigned text and other readings.
